RELEASE AND ELIGIBILITY FORM

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, in connection with my participation as a volunteer in the 2012 NBA All-Star Jam Session Staffing/Volunteer Recruitment Program (the "Program") with respect to the events and activities known collectively as the 2012 NBA All-Star Jam Session which is scheduled to take place February 22 – 26, 2012 at the Orange County Convention Center in Orlando, FL (the "Event"), I (the "Participant") hereby agree to serve as a Program volunteer and:

1. acknowledge and accept sole responsibility for all of the hazards and risks to me and my property associated with or related to my participation in the Program and/or the Event and for any damage or injury that I may cause to others;
2. release, waive and forever discharge any and all claims of damages or causes of action, including but not limited to, death, personal injury or loss or damage to property, which I or any of the my representatives, heirs, next of kin or assignees (my "Representatives") may have or which may hereinafter accrue to me or my Representatives as a result of my voluntary participation in the Program and/or the Event or otherwise and which may be asserted by me or my Representatives against NBA Properties, Inc., NBA Entertainment ("NBAE"), the National Basketball Association, any of its member teams, each sponsor, promoter or advertiser of the Event and any of their respective related entities, subsidiaries and affiliates and each of their respective officers, directors, owners, governors, officials, volunteers, employees, agents, representatives, successors and assigns (collectively, the "Released Entities"), howsoever caused, whether by the acts, omissions or negligence of any Released Entity or any other person or entity or otherwise;
3. grant permission to the Released Entities (or their respective licensees and/or designees) to utilize my name, voice, statements, photograph, image, likeness, actions and/or biographical data in any live or recorded form (including, but not limited to, any form of video display or other transmission or reproduction), in whole or in part, for promotional, commercial or any other purpose, in perpetuity worldwide in any media whether now known or hereafter created without any additional consideration;
4. represent that, if this form is not signed below by my parent or guardian, I am eighteen (18) years of age or older; and
5. acknowledge that NBAE is relying on the grant of rights contained herein.

The undersigned hereby (i) affirms the truth and correctness of the information provided above, (ii) authorizes NBAE, its related entities, its agents, representatives and designees to conduct an investigation of his/her background and to gather, in connection with such investigation, information about him/her that NBAE reasonably deems necessary and appropriate for the protection of NBAE's legitimate security interests in connection with the Event and (iii) authorizes any and all third parties to release any information that such third parties may have about him/her to NBAE.

The undersigned hereby releases the Released Entities from any and all claims arising directly or indirectly from the disclosure of information to NBAE pursuant to the foregoing authorization, including, but not limited to, claims relating to any investigations into the undersigned's background and any ineligibility to attend any NBA All-Star 2012 event (including, but not limited to, the Event) that may result from information gathered by NBAE.
